069/2015-16 Apologies for Absence.

Apologies for absence had been received from Patricia Athawes (late arrival), Christine West, Stuart Davenport (VWHDC), Richard Webber (OCC) and were <u>noted</u>.

070/2015-16 Public Participation.

There were 5 members of the public present.

(a) The Abingdon Centre for a Caring, Enlightened and Sustainable Society (ACCESS). Peter Coville (Coordinator) spoke about ACCESS and explained that it is a place where people can meet to reflect together on the major challenges facing society. The next event is 'What is a healthy economy?' on 11th July 2015 at 11 High Street.

(b) Subsidised Buses and Dial-a-Ride. Daniel Scharf (Public Transport Liaison Representative) reported on OCC's public meeting that was held on 6th July 2015 at Didcot Civic Hall.

(c) P14/V2504/FUL (see 87/2015-16 Planning Committee Business for full details). This application to build 73 dwellings on Land west of Abingdon Road was <u>approved</u> by the VWHDC Planning Committee on 10th June 2015. Daniel Scharf has sent a letter to the VWHDC that legally challenges this application. Matter continued under 077/2015-16 Drayton2020 Neighbourhood Plan (Richard Williams). (a) P14/V2504/FUL.
(d) Football Club. Richard Seamark will be submitting a grant application and spoke about the problems the football club has been having with its lawnmower. The old mower is broken and will cost circa £550.00 to repair and a new mower will cost £4,300.00.

ACTION: Deputy Clerk to send Ricard Seamark grant application form.

071/2015-16 Declarations of Interest, Dispensations and Use of Delegated Powers.

072/2015-16 Minutes.

Minutes of the Previous Parish Council Meeting held on 1st June 2015 were confirmed with no

073/2015-16 News from OCC Councillor (Richard Webber).

Richard Webber was unable to attend the meeting and had sent his report prior to the meeting.

'The Government's desire to increase the rate of housebuilding has been supported by the National Planning Policy Framework and by New Homes Bonus. The NPPF has certainly reduced many obstacles and delays to planning approvals. NHB, designed to encourage planning authorities to accept more housing in their areas has also played some part. Housebuilding is now steaming ahead, at least in the South of England. With the NHB allocation of 80% to District Councils and 20% to County Councils, District Councils in the South East, have seen their finances transformed. However, the resultant need for high cost infrastructure – roads and schools – falls to County Councils with only a 20% allocation of NHB, The increasing disparity between ever wealthier Districts and ever more financially stressed Counties is almost entirely the result of the 80:20% split of NHB. This Council requests that the Leader and CEO together with our local MPs and those of other Counties, the LGA and CCN put as much pressure on Central Government as possible to address the issue of NHB allocation between Districts and Counties.'

074/2015-16 News from VWHDC Councillor (Stuart Davenport). **Stuart Davenport was unable to attend the meeting.**

075/2015-16 Action Checklist from the Previous Meeting.

The action checklist from the last meeting was **<u>noted</u>** and the points below were provided as additional information:

(a) Litter. The communal litter pick with DAMASCUS will be held on 13th July at 6.30pm starting from the Village Hall. Refreshments will be provided at 7:30pm.

(b) Lock Way Playground. Patricia Athawes sent an email on 30th June 2015 to the Deputy Clerk with a brief for the Lock Way Playground attached.

ACTION: Patricia Athawes to write a specification for the Lock Way Playground.

It was **noted** that the Clerk received an email on 30th June 2015 from Teresa Hazelwood (Principal Landscape Architect, Pegasus Group) proposing the following for the South of High Street development - a natural play trail around the site, which will offer a range of play opportunities including climbing, balancing, swinging, spinning and imaginative play for all ages. The play opportunities are clustered in three locations along the footpath through the open space. As they are designed as a natural play trail we are not proposing any form of formal enclosure to the spaces, but could look to use mounding and planting to help define the spaces if desired. It was **agreed** to request an enclosed playground area for younger children so that older children do not preclude younger and that the ground is protected from animal droppings. Dog excrement is the usual problem (this trail will be used by dog walkers), but in this area there could also be foxes etc.

ACTION: Clerk to ask for an enclosed play area for younger children.

(c) Lyford Close BMX Track. Graham Webb has surveyed the area and it measures 1100 square metres. An allotment is traditionally measured in rods (perches or poles), an old measurement dating back to Anglo-Saxon times. 10 poles is the accepted size of an allotment, the equivalent of 250 square metres or about the size of a doubles tennis court. Most people would be happy with half of an allotment (125 square metres), so we might be able to fit 7 or 8 in this area. It was <u>noted</u> that there are a number of trees on the west edge including an oak tree with a spread of 15.5 metres.

ACTION: Graham Webb to layout allotments and investigate water supply. Deputy Clerk to consult Tim Atkins (Allotment Warden).

(d) Litter. The Deputy Clerk sent an email on 12th June 2015 to OCC waste management with a letter attached asking that they remove the litter in the ditch running alongside the Recycling Centre. **ACTION:** Deputy Clerk to check that litter has been removed.

078/2015-16 Village Green Land Registry (Clerk).

The Clerk received a letter dated 15th June 2015 from Carol Davis (Land Registry, Gloucester Office) stating that OCC claim the two parcels of land (at the north end of the Village Green) to be highway (except for the area of former pond that has been filled in) and should be vested in the highway authority pursuant to section 263 of the Highways Act 1980. It was **noted** that the Deputy Clerk sent an email on 9th June 2014 to OCC asking if the land was theirs and Nick Blacow (Senior Highway Procedures Officer, OCC) sent an email on 11th June 2014 to the Deputy Clerk stating that the area of land upon which the hedge has been planted is not part of the public highway. The Clerk sent an email on 22nd June 2015 to Jayne Fathers (Legal Assistant, OCC) asking her to explain how a year ago this land was not part of the public highway, but now

is and how, and when, it became public highway as this land was historically part of Drayton Village Green, since the 1815 Drayton Enclosure Act.

079/2015-16 Lockway Play Area (Patricia Athawes).

088/2014-15 Correspondence.

The items on the list of correspondence received were **<u>noted</u>**.

(a) **Dog Excrement.** The Clerk received an email via the website on 12th June 2015 from Kathryn Smyth complaining about dog excrement along the footpath that leads to the back school gate. Gary Marcham (Environment Warden, VWHDC) has been informed and anybody who is witnessed allowing their dog to foul without cleaning up will be issued with a £50 fixed penalty notice.

(b) Vale of White Horse Local Plan Examination. Planning Inspector, Mr Malcolm Rivett BA (Hons) MSC MRTPI has been appointed by the Secretary of State to conduct an examination into the soundness and legal compliance of the Local Plan. The Inspector will hold initial hearings between the 22nd September and 1st October 2015 within the Ridgeway Room of The Beacon, Portway, Wantage, Oxfordshire, OX12 9BX. These initial hearings will only consider the main strategic issues of the Local Plan and will not examine individual settlements or the sites identified for housing and employment allocations. The attached Matters and Questions Paper identifies specific questions which will be addressed during the initial hearings. Following the initial Hearings the Inspector will submit interim findings to the District Council, the content of which will determine the progress of the examination. Other matters such as the approach to Green Belt, the AONB and specific site allocations will be considered in due course should the examination progress.

089/2015-16 Items to be noted from Parish Councillors.

(a) Blue Plaque. Richard Williams <u>noted</u> that an application has gone into the Diocese requesting permission for the Blue Plaque to commemorate Rev FE Robinson who died on 16th February 1910. Rev Robinson was one of the most prolific ringers of his day. He rang in many record length peals, some taking 8 or 9 hours, and he became the first person ever to ring 1000 peals, which he achieved on 9th August 1905.
(b) Local Events. Tamsin Meredith <u>noted</u> the bring and share family picnic at the school on the 2nd August 2015 and Dfest on the 8th August 2015.

(c) **Drayton Chronicle.** Colin West would like to see more reporting from the Parish Council in the Chronicle.
