	 After discussion the financials in the Business Case were agreed for recommendation to the October Parish Council meeting subject to the following agreed elaborations and clarifications: The Executive Summary should be expanded to include reference to the financials, the various stages of the project (pitches/MUGA/car park/pavilion)/timescales and sources of funding for the various elements. The purpose of the business plan (to establish a viable funding model for funding applications) should be explained A project schedule should be included MUGA – a discussion on whether it is open/secure and charged for? The split between capital and operating costs should be flagged up more clearly
	• In table 9.2 the sports pitch maintenance sums should be footnoted to indicate how the assumed 10 year maintenance was arrived at, with appropriate caveats concerning the risks from these assumptions/advice
	• In table 9.3 the asterisk (*) should be explained with a footnote indicating that the Manor Farm funding can be used across all the sports facilities
	• Table 6 – the £35k for the 'outdoor gym' needs incorporating/splitting out in the fundraising target figures. The cash flow aspects of the fundraising need to be elaborated since these are poorly explained and difficult to understand at present
