We are a voluntary home-visiting scheme offering friendship along with practical and emotional support to vulnerable families with at least one child aged 5 years or under across the southern part of Oxfordshire. Volunteers visit families on a weekly basis for 2 – 4 hours to provide support in difficult times. We also run drop-in groups and a post-natal depression group and can help with preparing families when their child starts school.

We have 6 paid members of staff – Our part-time Senior Organiser leads a team of 1 part-time Organiser, 1 part-time Family Support Worker, 1 part-time Group Worker, a part-time Office Manager and a part-time Fundraiser.

# **DETAILS OF PROJECT:**

16. What is the project for which the grant is being sought? (Please give clear details of why the money is needed and how it will be used)

The ongoing support of one family costs approximately £1000 per year. This includes the salary of the Scheme Organiser who will manage the family and their volunteer, travel expenses for Organiser and volunteer along with admin costs. Due to cuts to funding in recent years we are currently unfunded across the Vale of White Horse area as a whole. As a result, we would be unable to accept any new referrals from Drayton families, should they arise. This is a position that we never want to be in. We are looking to secure £250 towards the cost of family support for new referrals in Drayton over the coming year. We will fund the remainder of the cost from other income streams.

Our fundraising group, the Friends of Home-Start Southern Oxfordshire, is made up of staff and volunteers who raise additional funds to support the scheme. They run events such as second hand book sales, street fairs and sponsored walks. We are fortunate to be supported by some individual fundraisers who choose to donate proceeds of their events to us. These have included "Bangers and Mash" lunches and sponsored silences. We are also applying to larger charitable trusts to try to secure core funding for the Vale of White Horse area as a whole.
