**Drayton Road, Abingdon
Carriageway Maintenance Works**

I am writing to inform you that Oxfordshire County Council will be undertaking carriageway maintenance works on the B4017 Drayton Road between the junctions of the A415 Marcham Road/Ock Street and Mill Road.

The works are programmed to commence on **Monday 27th July 2015** for a duration of 10 days, subject to any bad weather conditions or unforeseen circumstances arising during construction.

The works will include resurfacing of the existing carriageway, kerbing and road marking

Traffic Management

In order to keep traffic disruption to a minimum, the works will be undertaken in the following phases:

- Phase 1: Monday 27th July to Friday 31st July – temporary two-way traffic signals will be in operation from 09:30am to 15:30hrs to enable advance kerbing and drainage improvement works to be undertaken.
- Phase 2: Friday 31st July to Friday 7th August – six night-time road closures will be in operation, to enable the road resurfacing to be completed. The B4017 Drayton Road will be closed from 20:00hrs to 06:00am during this phase at the junctions with the A415 Marcham Road/Ock Street and Mill road. No works will be undertaken at weekends.

The attached plan highlights traffic diversion routes and extents of road closures. During the closure the alternative routes are:

B4017 Southbound (towards Steventon) / A4130 Eastbound / Milton Interchange / A34 Northbound / A415 Marcham Road (towards Abingdon) and vice versa.

Staff (traffic gatemens) will be positioned at either end of the site extents to redirect traffic and pedestrians to ensure the safety of the public and workforce during the road closure. We request that you give them your full support whether you are a pedestrian, cyclist or motorist.

Every effort will be made to accommodate essential vehicular access to properties and businesses adjacent to the works area but will be subject to progress of the works. Individual requirements will have to be agreed with the scheme supervisor, Stuart Priest, once the works have started on site (contact details below).
