## Minutes of the Drayton 2020 NDP Implementation Committee Meeting held at 7pm on Friday 20th January 2017 in St Peter's Church Hall, Church Lane

### **Minutes**

2017/001 Apologies for Absence. None

#### 2016/002 Declarations of Interest -None

**Dispensations** – Standing dispensation with regard to neighbours of planned developments, subject to no direct fiduciary benefit accruing

2016/003 Minutes of the Last Meeting. These were accepted without need of any substantive amendment.

#### 2016/004 Action Point Review

The Actions from the list - previously circulated - were reviewed

- (i) *Hilliat Fields Planting licence from OCC*. Still awaited
- (ii) Richard Webber is meting Perry Dotse (OCC Highways) about the Walnut Meadow roads matters this week
- (iii) *Leaflet on D2020 Project Plans/Financing*. Tom Shebbeare was arranging design and printing of this leaflet based on ideas submitted by the group (Tom/Andrew/Richard Wade)

#### 2016/005 Finance and Fundraising/s106 call off

The Hilliat Fields tree planning costs have been added in to the CALA s106 schedule

#### 2016/006 Update Report on the three proposed housing development sites

(a) *Barrow Road*. The following issues were raised:

#### **OCC Issues**

- i. *Thames Water sewer work on Barrow Road.* This work was completed before Christmas. The tarmac road surface is seen as temporary measure and Richard Webber is pursuing a more permanent solution with OCC/Millers and the Barrow Road residents.
- ii. *30 mph speed limit/junction design.* The move of the 30mph speed limit signs northwards towards Abingdon by 100 metres had been delayed by an objection, OCC would consider the matter at Committee in January.
- iii. The road junction splay did not yet conform. It was not known whether Millers had filed a design with OCC yet. Richard Webber is pursuing with Perry Dotse
- iv. *Private roads*. No news back from the lawyers on this issue yet. Richard Webber is also pursuing with OCC

v. *Traffic Calming scheme at north end of village*. Awaiting outcome of discussion between OCC Highways and Nigel Millington. OCC have written to the Clerk suggesting that the work is (a) not fully funded – they want £200k extra for the design work and a 40% contingency; (b) that the work should not commence until all the housing developments are completed (by which time the s106 funding from Millers would be lost – it only last 7 years and was paid to OCC in August 2016); c) that the parish Council does the work!

#### Parish Council Issues:

- vi. Playground design. Still no plans received from Millers
- vii. *Footpath lighting scheme*. Details of the lighting design had been received and also submitted to VWHDC, who will need to approve them. A metered electrical connection has been requested from Millers
- viii. Sports Fields drainage scheme. This has now been agreed with Millers
- ix. Fence behind Abingdon Road houses, bordering the drainage ditch. Still not fixed.
- x. *Open Ground*. No change. Millers are considering moving the spare earth to the northern boundary to form a noise bund

#### **VWHDC Issues**

- *xi. Planning Enforcement.* Stuart Davenport reported that the gap in the hedge on Barrow Road was now subject to a re-planting agreement with VWHDC. The site drainage issue is still an open enforcement issue
- (b) *South of High Street.* No start on site yet, but pre-commencement conditions are being discharged

(c) *Manor Farm*. Revised Planning Application has been lodged and the PC Planning Committee meets to discuss these next Monday. Thought would need to be given to the layout and use/facilities in the new Village Green. A Working Group composed of Tom Shebbeare/Andrew Bax/Richard Wade and two others from the west side of the village would be formed to consider this.

- (d) Halls Close. A meeting has now been arranged with Blue Cedar to discuss their plans
- (e) *East Way*. No further news.

### 2016/007 Project Group Updates:

- (a) Barrow Road Recreational Facilities.
  - (*i*) *Pavilion Design.* The final designs from the architects were tabled and considered.
  - (ii) MUGA –. Two other costings/designs were expected for the next meeting
  - (iii) Pitches. No further developments see above for January meeting with Millers
- (b) *Pre-School*. A meeting had been held at the School with OCC/Pre-School and School Governors. It now seemed likely that the Pre School will do the building and take the lease from OCC. VAT would need to be paid. A permanent building (i.e. not SIP) was preferred and the site and architects had been selected. A person to draw up a Business Plan had been identified. Fundraising for about £200k would be needed.
- (c) Footpath restoration project. Three very different quotes for this work had been received, and a fourth is now being sought. The MGT volunteers are continuing to widen and clear paths around the Millennium Green
- (*d*) *Artwork*. Tom/Andrew and the Clerk had met with the VWHDC Arts Officer, Abigail Brown to look at a specification for artwork in the form of three village gateway designs.
