**227/2017 Apologies for Absence.** Colin West, Colin Arnold, Richard Webber (late arrival and early departure).

**230/2017 News from OCC Councillor.** This item of business was deferred until Richard Webber's arrival later in the meeting. See item 233/2017 News from OCC Councillor.

#### 232/2017 Public Participation.

- (a) DAMASCUS Youth Project. Roxy Elford (Youth Worker) updated the Council on the work and activities going on in Drayton.
- **(b) Walnut Meadow Road Junction.** Mick Ferriman and Liz Ferriman expressed concerns with the new Walnut Meadow / Abingdon Road road junction that is dangerous due to poor visibility and speeding vehicles.

#### Pervin Shahin arrived at 7:45pm.

- **(c) GARD** (Group Against Reservoir Development). Derek Stork (Hon Chairman, GARD) updated the Council on the reservoir. It was <u>noted</u> that GARD is holding a public meeting on 15<sup>th</sup> November 2017 in Drayton Village Hall.
- (d) Walnut Meadow Screening. A Parishioner expressed disappointment that planting has not been put in yet to screen the new Walnut Meadow development from Abingdon.
- **(e) Manor Farm Conservation Area.** A Parishioner suggested removing the new Manor Farm development from the conservation area.
- **(f) Real Time Bus Information.** A Parishioner asked if / when real time bus information would be displayed at all the bus stops in Drayton. This was in the Neighbourhood Development Plan but it appeared that OCC had not requested funding for this from developers.

#### 233/2017 News from OCC Councillor (Richard Webber).

**Oxford Cambridge Expressway.** 3 expressway route options have been publicised. [Clerk's note: The short listed expressway routes are via Aylesbury, the EastWest Rail (EWR) corridor or the existing A421 corridor. The options include on and off-line improvements and a number of sub-options in order to route

around Oxford. All three expressway options include conversion of sections of the A34, A421, A428 and A1 to expressway standard to complete the route between the M4 and A14/M11. Each expressway option would form part of a package of transport measures including EWR, route technology, integration with rail interchange hubs and local access and mobility measures (including non-motorised users).]

(a) Footpath/Cycle path Improvements. It was <u>noted</u> that the post supporting the kissing gate at the Henleys Lane's entrance to the Millennium Green was so corroded it fell down.

**ACTION:** Clerk and Graham Webb to design a replacement post, meet with contractor and get a quotation to re-instate the kissing gate with disabled access, and to consult OCC to obtain permission for this work.

#### 240/2017 Planning Committee Business (Richard Wade).

**P17/V1225/RM.** Erection of 21 dwellings together with replacement garage for 10 Halls Close. Land to Rear of 10 Halls Close Drayton ABINGDON OX14 4LU.

**PC:** Objection: For the following reasons: Layout, Drainage, Transport and travel/footpath issues, Landscaping, Inadequate and incomplete information in the application. **VWHDC:** See Amendment: No. 1 - dated 19<sup>th</sup> July 2017.

**P17/V1508/DIS.** Discharge of conditions 4 - construction traffic, 7 - highways, 9 - landscaping, 10 - materials, 12 - Biodiversity Enhancement Plan, 13 - ecology survey & mitigation scheme details, 14 - slab levels and 15 - refuse storage on application ref. P15/V2828/FUL Development of 8 dwellings and new access road. Land Adjacent to 19 East Way Drayton ABINGDON OX14 4JZ

**PC:** The Planning Committee discussed the applicant's submission for discharge of its planning conditions and expressed concern about two matters requiring clarification: a) The proposed layout and surfacing of East Way. b) The consultation/information relating to construction materials delivery. **VWHDC:** Fully Discharged on 17<sup>th</sup> October 2017.

P17/V1225/RM Amendment: No. 1 - dated 19<sup>th</sup> July 2017. Erection of 22 dwellings together with replacement garage for 10 Halls Close.(As amended by plans and information received 19 July 2017). Land to Rear of 10 Halls Close Drayton ABINGDON OX14 4LU.

**PC:** Response [Clerks note: PC changed its comment to Objection after the meeting]: Please see our previous comments that have been ignored by the developer Blue Cedar, that appear to have taken little notice of the comments made by ourselves and various residents on site layout. They have squeezed in an extra house - 22 up from 21. No particular objection to that, but the opportunity to pull back the properties a tad from the northern boundary of the site (to allow a little more separation from existing residents) doesn't seem to have been considered. Drainage remains an issue, and OCC appear to think that the revised arrangements are inferior to the original scheme. The existing residents confirm that the site is known to have a high water table and there have been problems before with flooding, sewage backing up etc., so that getting this matter right could be crucial. **VWHDC:** Pending.
