2018/007 D2020 Projects Update

- (a) Walnut Meadow Sports Facilities. The Clerk will circulate the QS costings for the pavilion, which have been updated for current construction costs and contingencies. The sum is £1.1m, which need s to be divided into the cost of the building (Pavilion budget) and the costs of the outworks (storage/landscaping etc.) the letter to be part of the Sports Fields/Sports Facilities budget. Richard Williams reported on a meeting last week with OCC Highways at County Hall where he and Cllr Richard Webber were updated on the road junction works and the estate road adoption. The Clerk will circulate Richard Williams' notes on this meeting. The road junction requires legal work and notices to be given and this will take about 6 months. The drainage and kerbstones did not now seem to be an obstacle to the road adoption, once Millers have restored and tested the swales are working properly/
- (b) Pre School. Grants are now being sought
- (c) Footpaths. The kissing gate on the path from the Millennium Green is to be re-instated and to be paid for yet. The next project will be to complete the Gravel Lane path surface. Once CALA have finished there a quote will be sought for this
- (d) Traffic Calming. [Clerk's note: The speed limit signs have now been be changed from 50 mph to 40 mph]. OCC have yet to produce their traffic calming technical design and costings, The Clerk will chase this
- (e) Hilliat Fields Tree planting Clerk will chase OCC Trees Licence (again)

2018/007 Date of the next Meeting. Monday 16th April. 7pm. Drayton Village Hall (Small Hall) Lockway. It was agreed to bring meetings forward to 7pm since the third Monday each month conflicts with the Village Hall Management Committee which Tamsin Meredith attends as treasurer. It may be advisable to move meetings to a different Monday each month – to be kept under review
