Drayton (Vale): Pond, Sutton Wick Lane

Thank you for your letter dated 20 January 2003, to the Chief Executive, who has asked me to reply.

I can confirm that Sutton Wick Lane to the east of the pond is public highway and the responsibility of my department to maintain. However the areas you refer to, north and south of the pond are not highway. May I point out that Sutton Wick Lane runs more or less north to south with the pond on its west side. The attached plan will help to show this with north at the top. The extent of the public highway is coloured golden brown on the plan.

The approximate extent of Common Land No. 77 is shown edged by green dashed lines on the plan. You can see that it includes the pond and two open areas to the south but not the open area to the north. I have no other information on the area to the north of the pond or who other than your Council may own the common. I have therefore copied this letter to Christine Rodgers in the Chief Executives Department with a request that she writes to you in more detail about the ownership of Common Land No. 77. (*I have done it this way to suit you the speediest way!*)

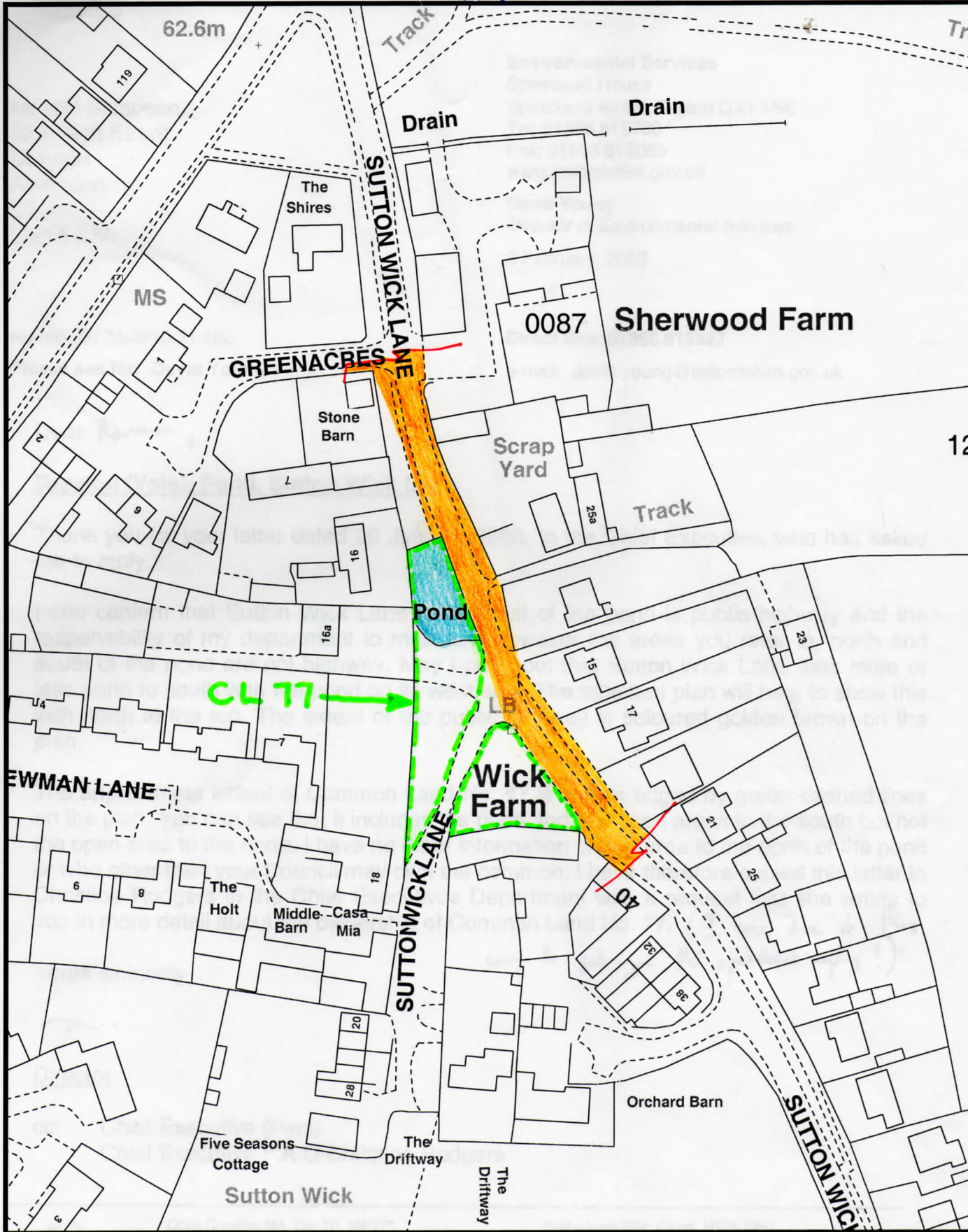
