# Minutes of the Meeting of Drayton Parish Council Held on Monday 1<sup>st</sup> December 2014 at 7:30pm At the Caudwell Day Centre, Gravel Lane, Drayton, OX14 4HF



**Present:** Richard Williams (Chairman), Laurence Zipson (Vice Chairman), Janet Manning, Graham Webb, Mark Jesson, Patricia Athawes, Naomi Broomfield (arrived at 7:35pm).

Not Present: Richard Webber, Stuart Davenport.

Parish Clerk and Meeting Administrator).

It was <u>noted</u> that the Parish Council is 120 years old, the first meeting was held on 4<sup>th</sup> December 1894.

#### 159/2014-15 Apologies for Absence.

Apologies for absence had been received from Richard Webber and were **noted**.

## 160/2014-15 Public Participation.

6 members of the public were present.

(a) **Doves.** Mr Mabbitt from Lesparre Close reported on excessive numbers of doves causing a mess and health issues. It was **noted** that this may be a matter for the VWHDC environmental protection team.

**ACTION:** Richard Webber to investigate the matter.

# Naomi Broomfield arrived at 7:35pm.

- **(b) P14/V2540/FUL** (see 173/2014-15 Planning Committee Business for details). David Russell from Gilbourn's Farm expressed concerns over the size of this proposed new farmyard complex development. Matter continued under 173/2014-15 Planning Committee Business (b).
- **(c) P14/V2531/FUL** (see 173/2014-15 Planning Committee Business for details). Paul and Wilmer Manthorpe from Milton Garden Machinery spoke and answered questions regarding the planning application to convert an existing maintenance building into a 2-bed single storey dwelling. Matter continued under 173/2014-15 Planning Committee Business (c).
- (d) **DAMASCUS Youth Project.** Roxy Elford (Youth and Community Work Area Manager) explained how the DAMASCUS Youth Project has been engaging with the local youth community.
- (e) **Drayton Football Club Grant Applications.** Richard Seamark is in the process of compiling the latest end of year accounts (2013-14) for the football club. It was <u>noted</u> that the Parish Council cannot authorise grant applications without this information.
- **(f) Community Garden.** Richard Seamark spoke about plans for a community garden at Stonehill House, Stonehill Lane.

#### 161/2014-15 Declarations of Interest, Dispensations and Use of Delegated Powers.

There were no declarations of interest at this stage of the meeting, nor any dispensations received in advance by the Clerk needed for consideration. There were no reports on use of delegated powers to report at this meeting.

#### 162/2014-15 Minutes.



#### 163/2014-15 Action Checklist from the Previous Meeting.

The Action checklist from the last meeting was **<u>noted</u>** and the points below were provided as additional information:

(a) New Beech Hedge on the Green, The Stables. Kerry Dearden (one of the owners of Stable barn) sent an email on 9<sup>th</sup> November 2014 to the Clerk reporting that her husband had removed the beech hedge. On 11<sup>th</sup> November 2014, the Parish Council collected leaves, strimmed and planted bulbs within the hatched areas shown below:



The Clerk has sent Katharine Brothers (Assistant Land Registrar, Land Registry Gloucester Office) more evidence that the land (title number: ON315203) adjoining The Stables, The Green, belongs to the Parish Council.

- **(b) Access around Golf Course.** The Deputy Clerk has telephoned Drayton Park Golf Club 3 times since the last meeting and has still not had a response to the email and letter he sent on 15<sup>th</sup> September 2014 to Jonathan Draycott (Director of Golf, Drayton Park Golf Club).
- (c) **FP14.** Minutes from 1<sup>st</sup> July 2013 state:

#### 055/2013-14 PUBLIC PARTICIPATION

(a) Car damage to Footpath FP14. On 23rd June, a group of young males managed to get a four wheel drive vehicle jammed in the ditch running alongside FP14. In so doing, or in trying to get the car out three sections of the railway sleepers that were originally used to reinforce the side of the path have been dislodged, a tree has been chopped down and a sizeable chunk of a wall has been destroyed in order to raise the vehicle out of the ditch. There has been considerable damage to private and Parish Council property.

The railway sleepers still need replacing. Mark Sumner (OCC Environment and Economy Countryside Service) sent an email on 11<sup>th</sup> November 2014 to the Deputy Clerk stating: "This issue is not of any priority to the council to repair however we will look at replacing/repairing it in due course."

(d) Sutton Wick/Casa Mia, Wild Flower area. The Deputy Clerk made a telephone call on 1<sup>st</sup> December 2014 to Wicklesham Quarry, Faringdon and obtained a verbal quotation for 5 or 6 rocks to be placed along a grass area to stop cars parking on it.

**ACTION:** Deputy Clerk to request a quotation from Adrian White Building Supplies, Kidlington.

- (a) Bank Reconciliation. Current account £44,635.53, Deposit Account £19,527.39, Undrawn cheques £18.00, Unbanked payments £650.00. Total funds = £64,794.92 excluding payments above.
- **(b) Grant Applications.** The Drayton Football Club grant applications were deferred to next month's meeting as the Parish Council cannot authorise these grant applications without the Football Clubs latest end of year accounts (2013-14).
- **(c) Payments.** The Clerk explained the payments listed above which were **approved** for payment. The list of online payments via Unity Bank (see items starred \* above) was signed off and the two people to approve online payments were appointed: Richard Williams and Naomi Broomfield. Richard Williams and Naomi Broomfield signed the cheques for the remaining (unstarred) payments.
- (d) **Budget Setting and Precept 2015-16.** On 24<sup>th</sup> November 2014, the Finance and Personnel Committee held a meeting and the recommendations from this meeting were considered by the Council.
- Agree the Parish Council Budget for 2015-16. It was <u>Resolved</u> to accept the recommendation laid out by the Finance and Personnel Committee.

■ Set the Level of Charges for 2015-16. The following increases were recommended: Allotments: With effect from 1st April 2016 (1 year's notice): £12.00 charge to be raised to £15.00; £6.00 to be £7.50; £9.00 to be £11.25. Burials: With effect from 1st April 2015: Charges to be £55.00/£110.00/£125.00 & £250.00. It was **Resolved** to accept the recommendation laid out by the Finance and Personnel Committee.

Proposed: Graham Webb Seconded: Janet Manning Resolved: Unanimously

■ Set the Precept for 2015-16. In order to achieve a balanced budget the precept recommended is unchanged from this year's level of £40,000.00. On the basis of the expenditure, charges and precept above, a balanced budget with income and expenditure of £61,800.00 (including £18,000.00 moved from Reserves). It was Resolved to accept the recommendation laid out by the Finance and Personnel Committee.

(e) 2014-2016 National Salary Award. It was <u>noted</u> that the Clerk and Deputy Clerk will receive a pay award on  $1^{st}$  January 2014 as a one-off payment of £100.00.

#### 165/2014-15 Drayton2020 Neighbourhood Plan (Richard Williams).

- (a) Drayton Neighbourhood Development Plan 2014-2031 (NDP). The independent examiner of the NDP (Alyson Linnegar) has decided to hold a public hearing which will take place on 12<sup>th</sup> December 2014 at Drayton Village Hall. The hearing is open to members of the public to attend, but only invited representatives will be permitted to take part in discussions. Richard Williams will represent the Parish Council. After carrying out the hearing the examiner will deliver her report (the examiner's report), which will set out whether the plan should proceed to the next step of a local referendum and if so whether the plan should be modified in any way before it is subject to a local referendum.
- **(b) Traffic Calming Workshop.** This public event was held on 21<sup>st</sup> November 2014 and around 70 Draytonian residents attended. Tom Shebbeare (Drayton2020, Vice Chairman) welcomed people, Nigel Millington (Phil Jones Associates, transport planning consultants) gave a presentation in which he said that traffic movements are increasing with the increasing population and Paul Fermer (Locality Manager, OCC) answered questions on behalf of OCC. The obvious solution to traffic is to build bigger and better roads but this isn't always the answer, with bigger and better routes, people tend to use them more. Like water finding the easiest path.

**166/2014-15** Calendar dates **2015.** The dates for the 2015 Parish Council and Finance & Personnel Committee meetings were <u>agreed</u>. The General, Vale and Parish elections will all be held on 7<sup>th</sup> May 2015 and the old Council will retire 11<sup>th</sup> May 2015. It was <u>noted</u> that the 11<sup>th</sup> May 2015 may be a bit tight if the Parish Council election is contested.

167/2014-15 New Beech Hedge on the Green, The Stables.
